### Sleepover

Sleepover shifts are available and will be quoted case by case depending on what time the sleepover shift starts and ends and is charged as per the Personal Care rates included in the price list.

All staff are paid in accordance with the Sir Moses Montefiore Jewish Home Enterprise Agreement. As per the Agreement, staff should sleep 8 hours during a Sleepover Shift, otherwise an hourly rate will apply for each time woken between the hours of 10pm and 6am. Four hours of care must also be provided prior to and/or following a sleepover shift to conform with the Agreement requirements. The rate will be determined by the start and end times of the sleepover shift.

Each sleep over shift will incur an additional charge of \$133.90 which is paid directly to the carer as a “sleepover allowance” as per our Enterprise Agreement (Clause G9 & G14)
